RELEASE AND WAIVER
OFF-CAMPUS PROGRAM

1. In consideration of being permitted to participate in the _____ (name of course or program) and all activities directly or indirectly related thereto, I, the undersigned, in full recognition and appreciation of the responsibilities, hazards and risks inherent in my participation in said program including, but not limited to, any risks associated with travel and stay in _____ (country/regions), with transportation to and from _____ to the United States, and with social or after-hour activities, do hereby agree to assume all such risks and responsibilities. I further agree, for myself, my heirs and personal representative(s) to forever exempt and release Colorado College from any and all liability, claims, demands or causes of action whatsoever, arising out of any loss, damage or injury to me or my property, while engaged in the aforementioned activities, whether such loss, damage or injury results from the negligence of Colorado College or from some other cause, with the sole exception of intentional acts or willful and wanton negligence on the part of Colorado College.
2. I also release Colorado College, and agree to hold harmless and indemnify the College, with regard to any financial obligations or liabilities that I may personally incur or any damage or injury to the person or property of others that I may cause, while participating in the off-campus abroad program.
3. I grant Colorado College full authority to take whatever actions the program leaders may consider to be warranted regarding my health and safety. I authorize Colorado College, at its discretion, to place me, at my own (or my parents') expense, and without any further consent, in a hospital within or outside the United States for medical services and treatment or, if no hospital is readily available, to place me in the hands of a local medical doctor for treatment. I authorize Colorado College to transport me back to the United States by commercial airline at my own (or my parents') expense if deemed necessary.
4. I agree that the program leaders shall have the right to enforce appropriate standards of conduct and that they may at any time terminate my participation in the off-campus program for failure to maintain these standards or for any actions or conduct which they consider to be incompatible with the interest, harmony, comfort and welfare of other students. If my participation is terminated, I consent to being sent home at my own (or my parents') expense with no refund of tuition or fees.
5. Program leaders assume advisory, not supervisory, responsibility for the personal conduct of group members. Questions concerning hours, free time, drinking and other personal behavior require personal decisions by students for which Colorado College does not assume responsibility. As an American student in a foreign country, I understand I am subject to the laws of the host country.
6. All references in this Release to Colorado College shall include Colorado College and all of its officers, trustees, directors, faculty, staff members, campus directors, group leaders, employees, students, advisors and agents.
7. By my signature affixed hereto, I certify that I have read this Release in its entirety and understand the contents and obligations which it imposes upon me.

PART VI:

STUDENT INSURANCE COVERAGE FOR OFF-CAMPUS PROGRAM ABROAD
